Here is an abstract for 56th symposium paper.

Risk mitigation in large commercial helicopters. The case for limited exposure to engine failure.

The introduction of large commercial helicopters (over 20,000 pounds gross weight with more than 9 passenger seats) would normally dictate Category A operations with no exposure to engine failure. However, the dynamic Category A takeoff and landing profiles may be more hazardous, due to the potential for pilot error, than the risk of an engine failure. Many civil aviation authorities recognize this dichotomy of hazards and have implemented operating rules which permit limited exposure to engine failure to decrease the risk of accident due to pilot error.

This paper will identify the flight profiles which present the highest risk of engine failure and pilot error. It will look at the history of accidents due to the different risk factors and then detail the options to mitigate these risks. The paper will also include the flight test techniques required to develop the takeoff and landing procedures with an emphasis on efficiency of data collection (minimize test points).
